Augusta, GA - Wenona Mercer Carter, 52, passed away June 16, 2013, at University Hospital, after a long battle with Scleroderma.

In her teen years, Wenona loved sports and participated in cheerleading, softball and basketball, later coaching a youth girls basketball team to the Richmond County championship. In her adult life, she was employed by Ladybug pest control, Lily Tulip and Physicians' Practice Group before becoming an independent Tupperware rep where she earned her own van. Her last job was as library assistant at Segoo Middle School.

As a member of the Evans Church of Christ, she enjoyed singing gospel, attending church and being with friends and family. A loving mother, daughter, sister and friend, she battled Scleroderma for over 25 years and was a 2 time cancer survivor.
